

Dear Mr Hennessey,

Following your recent interview for employment with this Company, we now have pleasure in confirming your appointment as an Aircraft Maintenance Engineer to commence Monday, 7th January, 1985.

Outlined hereunder are the basic conditions of employment covering the position of A.M.E. in accordance with the Aircraft Industry Award.

Commencing salary will be \$317.00 per week, plus appropriate penalty rates if employed on shift work.

Annual leave four weeks, plus one additional week if regularly rostered to work on Sundays and Public Holidays.

Sick leave entitlement will be one week on commencement, plus one additional week after six months service, plus three weeks each twelve months thereafter on the anniversary of your commencement date. Sick leave in excess of ~~three~~ days in any one year must be substantiated by a medical certificate.

As is our Company policy, your appointment is subject to a three month's probationary period, after which your appointment will be confirmed as a member of our permanent staff.

Superannuation is available after an eligibility period of two years, on an equal employer - employee contributory basis.


