

**Ansett Australia Ground Staff Superannuation Plan Pty Ltd and Others - v -
Ansett Australia Ltd (Administrators Appointed) and Others
Supreme Court Proceeding No 2115/01**

We refer to previous discussions. We confirm the administrators' request that you appear in this action to put before the Court the viewpoint of an unsecured creditor.

The plaintiff trustees have indicated they are not going to press one outcome rather than another before the Court. It is unlikely that the Administrators will take a particular position in the proceeding. The interests of retrenched employees and continuing employees are to be represented by separate defendants. It seems reasonably clear that the interests of the unsecured creditors of the Ansett Group might be significantly different from those other interests represented before the Court.

In these circumstances, we believe there is a need for an unsecured creditor to either join the proceeding as a party or to appear before the Court to argue the case for unsecured creditors.

We confirm that the administrators indemnify you in respect of the costs of the proceeding.
