1. I am a member of Deacons, the solicitors for the plaintiffs. I am authorised to swear this affidavit on their behalf. I do so from my own knowledge, save where otherwise indicated.
2. This affidavit is supplementary to my affidavit sworn on 10 July 2002.
3. In paragraph 6 of that affidavit, I referred to an application by the Administrators to the Federal Court of Australia on 22 January 2002 (proceeding no. V3010/02) seeking approval of the proposed sale of the Ansett mainline business to the TESNA consortium. The document numbered 7.1.192 in the plaintiffs' index of documents is a copy of the transcript of the hearing of that proceeding on 30 January 2002.
